A FACT SHEET

The Asian Development Bank (ADB) is dedicated to reducing poverty in the Asia and Pacific region through pro-poor sustainable economic growth, social development, and good governance. Established in 1966, it is owned by 66 member nations—47 from the region—who have committed \$116 billion to the vision of a region free of poverty.

Canada is the seventh largest shareholder and has contributed \$2.65 billion in capital subscription and \$1.73 billion to special funds since joining in 1966. Despite successes, the region is still home to two thirds of the world's poor: nearly 1.9 billion people who live on \$2 a day or less, with 620 million struggling on less than \$1 a day.

Canadian companies and consultants have been awarded \$822 million in procurement contracts on ADB-financed projects since 1967.

In 2005, ADB approved \$6.95 billion in loans and grants for projects and technical assistance of \$198.7 million. This also generated \$7.4 billion in cofinancing from commercial financial organizations, official funding institutions, and export credit agencies, with \$9 million from Canadian sources.

In addition to project loans, grants, and technical assistance, ADB uses guarantees and equity investments to help its developing member countries.

With headquarters in Manila, it has 26 offices around the world and more than 2,000 staff from over 50 countries.

Shareholding and Voting Power

Canada is the second largest shareholder in ADB among 19 nonregional members. Overall, Canada is the seventh largest shareholder.

Contributions to Special Funds Resources

Canada has contributed to the original and all subsequent replenishments to the Asian Development Fund (ADF), which is ADB's window for concessional lending to its borrowing members, and to the Technical Assistance Special Fund (TASF), which provides grants to borrowing members to help prepare projects and undertake technical or policy studies.

Contributions to the ADF (committed): \$1.70 billion

Contributions to the TASF (committed): \$29.98 million

Channel Financing/Administrative Arrangement

The Administrative Arrangement (AA) establishing the Canadian Cooperation Fund on Climate Change for a total contribution of Canadian dollar (Can\$)5 million (approximately \$3.2 million) was signed between Canada and ADB on 27 March 2001. Current priorities are greenhouse gas emissions reduction in the People's Republic of China and India; carbon sequestration in Indonesia; and adaptation to climate change in the Pacific developing member countries (DMCs). The second AA was signed between Canada and ADB on 29 November 2001 for a total contribution of Can\$2.5 million (approximately \$1.6 million) for the Governance Cooperation Fund. Current priorities are government-led governance reform activities in ADB DMCs. On 11 April 2003, ADB signed the third AA with Canada as one of the initial contributors to the Gender and Development Cooperation Fund, a multidonor trust fund. Canada contributed Can\$1.2 million (approximately \$0.8 million) to this trust fund. Current priorities of this trust fund are program activities within the scope of ADB's *Policy on Gender and Development* and *Gender Action Plan* in ADB DMCs.

On 14 July 2004, ADB signed the fourth AA with Canada as one of two contributors to the Cooperation Fund in Support of Managing for Development Results with a contribution of Can\$1 million (approximately \$0.75 million) for activities relating to promotion of results management techniques in ADB DMCs.

Cofinancing

ADB arranges cofinancing from commercial and official sources as additional resources for project financing. Cofinancing arrangements in 2005 amounted to \$7.4 billion for 31 public and 3 private sector projects and \$77.9 million in untied grant financing for 95 technical assistance projects. At the end of 2005, cumulative cofinancing arrangements (beginning 1970) amounted to about \$49.5 billion for 692 loan projects and \$531.7 million for 727 technical assistance projects.

Share of ADB's Procurement Contracts

Each year, ADB provides loans to fund projects and activities in its Asian and Pacific developing members and several billion US dollars' worth of contracts to procure goods and consulting services.

From 1 January 2001 to 31 December 2005, ADB approved about \$28.12 billion in loans for 323 projects and \$892.1 million in technical assistance for 1,509 projects. As of 31 December 2005, the cumulative totals were \$116 billion in loans for 1,940 projects in 39 countries and \$2.78 billion for 5,923 technical assistance projects, including regional technical assistance projects.

Procurement contracts for goods and related services, civil works, and consulting services under loan and technical assistance operations totaled \$3.5 billion in 2004 and \$5.7 billion in 2005. Cumulative procurement as of 31 December 2005 was \$80.6 billion. Most contracts were awarded on the basis of international competition, which is open to firms and individuals from any ADB member country, regional or nonregional.
